#### **President's Report:**

Contract and Bylaw Ratification:

- Our New bylaws are in place. I want to thank the committee who worked diligently and thoughtfully through each section of the bylaws: Maria DeOcampo, Rhea Vigay, Diane Zimmermann, our counselor Ricardo Ochoa, and our team leader Courtney Davis Martin. - The contract was ratified overwhelmingly, with only 1 "No" vote. Again, please reference our website for a summary of changes. The new contract will be available soon; it is currently being prepared for printing. Important to note:
  - Compensation increase of 1%, which is divided between our longevity schedule and the salary schedule. .037% will go to longevity and .63% will go to across the board salary increases. We have a "me too" clause in case any other bargaining unit is able to negotiate a higher increase than 1%. The contract is retroactive to July 1, 2013.
  - Financial Incentive Program- people who take coursework that directly relates to their
    jobs will be able to seek reimbursement. A committee is being formed and will be
    meeting to set dates for applications so we can get started as soon as possible.
  - A Safety Committee will be needed to implement our new agreement regarding safety related issues.
  - Pension reform. "Classic" employees will have an opportunity to choose whether or not they would like to start paying their own contribution toward retirement or continue with employer-paid contribution.
  - Retirement Seminars and Pension Option Info Meetings.

CalPERS Seminars. We will hold pension option meetings in October. There will be two. The dates will be published next week. Additionally, we have invited Marc Houle back to run two CalPERS seminars: Oct 19th and Oct 26th. Both will be held from 9 am to noon at the Poway Federation of Teachers at: 11031 Via Frontera, in Rancho Bernardo. Also, Marc will be available with me for drop in, one-on-one sessions, Monday through Thursday the week of Oct 21<sup>st</sup>, from 4 to 7 p.m. in the evenings.

## Current Employee Issues

• I have been working on various employee issues. One deals with an employee who missed the first two days of school; several are leave of absence denials; various transfer problems, etc. The rest of the time has been spent working on getting the contract ratified.

Insurance Committee. The insurance committee has been in full swing. Linda, Mary Jo and I have been attending. Barney and Barney obtained bids for us to review because Health Net was projected to increase by 16%. They did come down from their initial bid to a 12% increase, but Aetna was a better offer and was chosen by the Committee. We will see an increase in our cost, as expected, but instead of 12% it will be 8.7%. Kaiser continues to offer the same rates and will not be increasing. PSEA will be able to supplement your premiums with our distribution from the post-retirement account, which was increased with this year's contract negotiation. Open enrollment will begin soon and everyone who was in Health Net and who will be choosing either Kaiser or Aetna must re-enroll. You can't let anything roll over (unless you are currently a Kaiser member).
