- Change Food Services in section 5.2 to Food and Nutrition.

• In accordance with current district practice, revise section 7.1 to reference vacation amount for 12 month employees, and add wording to section 7.1 to state that vacation days per year shall be prorated for less than 12 month employees.

#### Article 8 Holidays

• Maintain current contract provisions.

#### Article 9 Leaves of Absence

• Maintain current contract provisions except to add new provisions for AB2393.

#### Article 10 Health and Welfare Benefits

• Update current agreement to reflect recent changes in the article.

• Maintain current contract provisions.

## Article 18 Wages

- Revise to reflect recent contract settlements.
- Delete section 18.7.
- Revise section 18.8 to reflect recent Memorandum of Understanding regarding uniforms, safety shoes/boots and prescription safety lenses.
- Review and revise section 18.11.

#### Article 19 Transportation Department Provisions

• Maintain current contract provisions.

#### Article 20 Term of Agreement

• District proposes to include a new article 20 addressing layoff, reemployment and related negotiations. The provisions in this article shall be consistent with Article 15 in the PSEA Unit I agreement.

#### Article 21 Term of Agreement

• Three-year agreement.
